****PART 61 RATED PILOTS****

If you are already a Part 61 rated pilot, great! The good news is that you don't have to take the FAA written knowledge test like everyone else. All you need is to pass an online quiz put forth by the FAA and receive an initial sign-off from a Certified Flight Instructor or other designated person. This course can definitely benefit you with preparing for the quiz and receiving that sign-off, along with providing valuable hands-on instruction with our own unmanned aircraft. Just be sure that you bring proof of a valid flight review completed within the previous 24 months. If you need a flight review, we can also help you accomplish that right here at our flight school! Call ahead of time for proper arrangements.
