



## CERTIFIED FLIGHT INSTRUCTOR INITIAL COURSE DESCRIPTION

### COURSE OVERVIEW

Welcome to 360 Aviation's Certified Flight Instructor Course. This course is intended for the initial certification of a flight instructor certificate (Airplane Single Engine). This accelerated 10-day course will teach you how to instruct the aviators of tomorrow. The course will begin with three days of ground school that cover the Fundamentals of Instructing, then progressing on to other technical subject areas along with learning to teach all of the commercial and private pilot maneuvers from the right seat. This course assumes that your aeronautical knowledge is at least at a commercial pilot level, which may require you to brush up on any weak areas before arriving. The initial CFI check ride is arguably the toughest check ride to pass, and this course is equally as demanding. You will cover a lot of information over the 10-day course, so pre-studying will be beneficial. The end result is definitely worth it and there are few things as rewarding as becoming a Certified Flight Instructor. You will need to work hard in between lessons, reviewing ground and flight items introduced previously, while also completing any homework from your instructor to prepare for the next lesson. Personal preparation and studying is the key to reducing costs and passing your check ride.

### COURSE PREREQUISITES

- \$500 deposit to 360 Aviation, LLC.
  - Deposit will be deducted from your course fee upon arrival
  - This deposit secures your scheduled start date with us and is non-refundable
- U.S. Passport (unexpired) or Original Birth Certificate
  - No flight training can take place until this is received
- FAA Commercial Pilot Airplane or ATP Certificate
  - Instrument (Airplane) Rating Required
- Current FAA Medical (3<sup>rd</sup> Class minimum)
- Fundamentals of Instructing (FOI) Written Passed
- Flight Instructor Airplane (FIA) Written Passed

- Current 3<sup>rd</sup> Class Medical or greater
- Pilot Logbook(s) with flight times totaled
- Airman Knowledge Test Report (FIA and FOI)
- Cash/Check for Examiner Fee
- Headset (dual plug GA)
- View limiting device (foggles or hood)
- Laptop - for manuals, documents, and lesson plan development/presentation

### ACCELERATED COURSE FEE OPTION

Our accelerated instrument course is 10 days in length, working 8 hours each day. This is the fastest way to get your certificate! The accelerated course fee includes all flight and ground instruction for the course, along with any in-house procured materials, and guarantees one of our instructors will work with you each day on the ground and/or in the air. If needed, we will provide an extra two days at no additional cost (up to 12 days included in the course fee). If there is a weather or maintenance delay, you will not be charged for extra days to finish up. However, if you require additional training or leave for any reason, you will then be charged at the hourly or daily rate.

### FLEXIBLE HOURLY OPTION/FINISH-UP

If you work, go to school full time, or can't train 8 hours a day, we offer an hourly option that can be customized to fit around your schedule. This is also the option for you if you've started your training elsewhere and would like to finish up with us. Our instructors are often available day or night, weekdays and weekends, to accommodate your training needs. This option allows you to pay as you go so you only pay for what you need. - All Logbooks With All Required Inspections
- Airworthiness Certificate
- Valid Registration (State and Federal)
- Operating Manual and Limitations
- Current Weight & Balance
- Proof of Insurance
