



COMMERCIAL PILOT COURSE DESCRIPTION

COURSE OVERVIEW

Welcome to 360 Aviation's Commercial Pilot Airplane Course. This course is intended for the initial commercial pilot certification in a single engine airplane. If you have flight experience in other types of aircraft or if you are looking to get a commercial certificate for an additional category of aircraft, please give us a call! We offer an accelerated 5-day course as well as a flexible hourly option to train at your own pace (see below for more details). The hourly option is "pay-as-you-go" where your instruction is billed at an hourly rate, while the 5-day course has a bundled course fee that includes all instruction. The Commercial Pilot Course will teach you to act safely and effectively as a commercial pilot, and is a required stepping stone for any flying career in aviation. This course is designed to get you through the commercial certificate quickly, while still gaining the advanced experience necessary to be a safe and proficient pilot. You will need to work hard in between lessons, reviewing ground and flight items introduced previously, while also completing any homework from your instructor to prepare for the next lesson. Personal preparation and studying is the key to reducing costs and passing your check ride.

PREREQUISITES PRIOR TO STARTING

- \$500 deposit to 360 Aviation, LLC.
 - Deposit will be deducted from your course fee upon arrival
 - This deposit secures your scheduled start date with us and is non-refundable
- Original Birth Certificate or unexpired U.S. Passport
 - No flight training can take place until this is received
- Current FAA Medical (3rd Class Minimum)
- FAA Private Pilot Airplane Certificate
- Minimum 18 Years of Age
- Commercial Pilot Airplane (CAX) Written Test Passed
- Minimum 235 Total Time (with flight experience of 61.129(a) i.e. Complex/TAA, Night, PIC, etc.)
 - Long solo cross-country requirement complete (see 61.129(a)(4)(i))
 - If short of these hours or requirements, prior arrangements can be made. **Additional Fees Apply** Call us if you have any questions on the requirements!

PILOT SUPPLIES TO BRING

- Government Issued Photo ID (Driver's License, Passport, Military ID)
- Private Pilot Airplane Certificate
- Current 3rd Class Medical or greater
- Pilot Logbook(s) with flight times totaled
- Commercial Airplane (CAX) Knowledge Test Report
- Cash for examiner (see expenses below)
- Headset (dual plug GA)
- Notebook and writing utensils, we also recommend bringing a 3-ring binder for documents
- Laptop, if wanting to download and use our manuals and documents

ACCELERATED COURSE FEE OPTION

Our accelerated commercial course is 5 days in length, working 8 hours each day. This is the fastest way to get your certificate! The accelerated course fee includes all flight and ground instruction for the course, along with any in-house procured materials, and guarantees one of our instructors will work with you each day on the ground and/or in the air. If needed, we will provide an extra day at no additional cost (up to 6 days included in the course fee). If there is a weather or maintenance delay, you will not be charged for the extra days needed to finish up. However, if you require additional training or leave for any reason, you will then be charged at the hourly or daily rate.

FLEXIBLE HOURLY OPTION

If you work, go to school full time, or can't train 8 hours a day, we offer an hourly option that can be customized to fit around your schedule. This is also the option for you if you've started your training elsewhere and would like to finish up with us. Our instructors are often available day or night, weekdays and weekends, to accommodate your training needs. This option allows you to pay as you go so you only pay for what you need. If you have any questions, please call for a quote to decide which option will work best for you.

- Operating Manual and Limitations
- Current Weight & Balance
- Proof of Insurance
