

# AIRLINE TRANSPORT PILOT COURSE DESCRIPTION

#### **COURSE OVERVIEW**

Welcome to 360 Aviation's Airline Transport Pilot course. This 3-day airline transport pilot course will teach you to safely work for an airline and achieve the "Doctorate Degree of Aviation." This course does require extensive preparation in order to take the written test, which is a prerequisite to taking the course. We will work with you during the day, but you must work each night reviewing ground and flight items introduced that day, as well as previously taught subjects. Personal preparation and studying will allow you to pass the check ride with ease.

### PREREQUISITES PRIOR TO STARTING

- \$850 deposit to 360 Aviation, LLC.
  - Deposit will be deducted from your course fee upon arrival
  - This deposit secures your scheduled start date with us and is <u>non-refundable</u>
- FAA Commercial Pilot Airplane Certificate (for ATP rating sought)
- ATP Written Test Complete
- Current FAA Medical (3<sup>rd</sup> Class minimum)
- 1500 Hours Total Time (61.159)
  - o 500 Hours X-C
  - o 100 Hours Night
  - o 50 Hours in Class sought (Multi Engine Land, etc.)

#### **PILOT SUPPLIES TO BRING**

- Government Issued Photo ID (Driver's License, Passport, Military ID)
- U.S. Passport (unexpired) or Original Birth Certificate
- Commercial Pilot Certificate (Plastic Card and English Proficient)
- Current 3<sup>rd</sup> Class Medical or greater
- Pilot Logbook(s) with flight times totaled
- Written Test (ATP) Knowledge Test Report
- Cash/Check for Examiner
- Headset (Dual Plug GA)
- Notebook and writing utensils

## **ACCELERATED COURSE FEE OPTION**

Our accelerated ATP course is 3 days in length, working 8 hours each day. This is the fastest way to get your certificate! The accelerated course fee includes all flight and ground instruction for the course, along with any in-house procured materials, and guarantees one of our instructors will work with you each day on the ground and/or in the air. If needed, we will provide an extra day at no additional cost (up to 4 days included in the course fee). If there is a weather or maintenance delay, you will not be charged for extra days to finish up. However, if you require additional training or leave for any reason, you will then be charged at the hourly or daily rate.

#### **BRING YOUR OWN AIRPLANE**

We can do that! Make sure that the maintenance logs are current and the aircraft is airworthy and IFR certified with current IFR databases. Please call to inquire beforehand. Must bring the following:

- All Logbooks With All Required Inspections
- Airworthiness Certificate
- Valid Registration (State and Federal)
- Operating Manuals and Limitations
- Current Weight & Balance
- Proof of Insurance

- Current Charts, Approach Charts, low enroute charts, AFD
  - We recommend bringing an iPad with Foreflight or an equivalent program
- Current FAR/AIM
- Aircraft Specific POH (digital or paper version)
