

# CERTIFIED FLIGHT INSTRUCTOR-INSTRUMENT ADD-ON COURSE DESCRIPTION

#### COURSE OVERVIEW

Welcome to 360 Aviation's Certified Flight Instructor Instrument add-on course. This course is intended as an add-on rating to your current (unexpired) flight instructor certificate. If your CFI has expired, give us a call! This 3-day add-on course will provide you with the necessary knowledge and skill to safely train students for an instrument rating, for the instrument training required for a commercial certificate, or to provide an instrument proficiency check. If you are interested in obtaining your Multi-Engine Instructor rating in the future, give us a call as we offer a discounted CFII/MEI combination course! This course can be used to renew your current flight instructor certificate as long as it has not expired. You will need to work hard in between lessons, reviewing ground and flight items introduced previously, while also completing any homework from your instructor to prepare for the next lesson. Personal preparation and studying is the key to reducing costs and passing your check ride.

#### **COURSE PREREQUISITES**

- \$850 deposit to 360 Aviation, LLC.
  - Deposit will be deducted from your course fee upon arrival
  - This deposit secures your scheduled start date with us and is non-refundable
- U.S. Passport (unexpired) or Original Birth Certificate
  - No flight training can take place until this is received
  - FAA Certified Flight Instructor Airplane Certificate (unexpired)
    - If your CFI has expired, give us a call! We can still work with you, there will just be additional requirements, time, and cost.
- Current FAA Medical (3<sup>rd</sup> Class minimum)
- Flight Instructor Instrument Airplane (FII) Written Passed

## PILOT SUPPLIES TO BRING

- Government Issued Photo ID (Driver's License, Passport, Military ID)
- U.S. Passport (unexpired) or Original Birth Certificate
- Commercial Pilot Certificate (or ATP) with Instrument Privileges
- Flight Instructor Airplane Certificate (unexpired)
- Current 3<sup>rd</sup> Class Medical or greater
- Pilot Logbook(s) with flight times totaled
- Cash/Check for Examiner Fee
- Headset (dual plug GA)
- View limiting device (foggles or hood)
- Notebook and writing utensils, we also recommend bringing a 3-ring binder for documents
- Laptop for manuals, documents, and lesson plan development/presentation

#### ACCELERATED COURSE FEE OPTION

Our accelerated CFII course is 3 days in length, working 8 hours each day. This is the fastest way to get your rating! The accelerated course fee includes all flight and ground instruction for the course, along with any in-house procured materials, and guarantees one of our instructors will work with you each day on the ground and/or in the air. If needed, we will provide an extra day at no additional cost (up to 4 days included in the course fee). If there is a weather or maintenance delay, you will not be charged for extra days to finish up. However, if you require additional training or leave for any reason, you will then be charged at the hourly or daily rate.

## FINISH-UPS/FLEXIBLE HOURLY OPTION

If you've already started your training elsewhere or you simply cannot complete this course in one go, we offer an hourly/daily rate that can be customized to fit around your schedule. Our instructors are often available day or night, weekdays and weekends, to accommodate your training needs. The course fee is the best option for someone looking to complete the entire course with us, but a daily fee can be arranged, if needed. - Current Weight & Balance
- Proof of Insurance
